## INVESTMENT OBJECTIVE

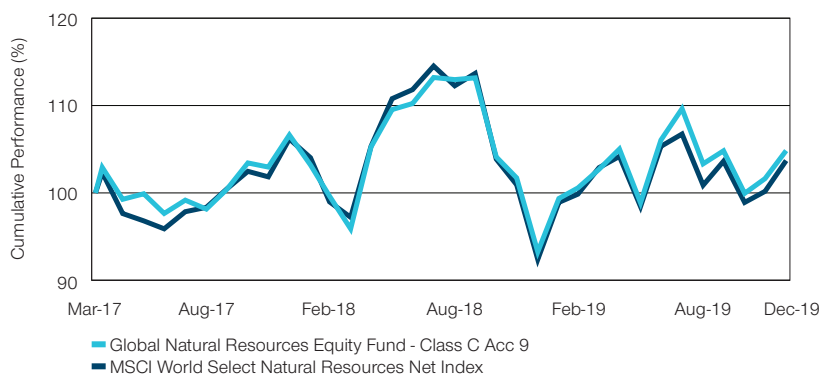
