

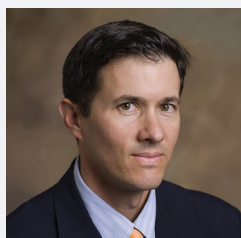

INVESTMENT OBJECTIVE

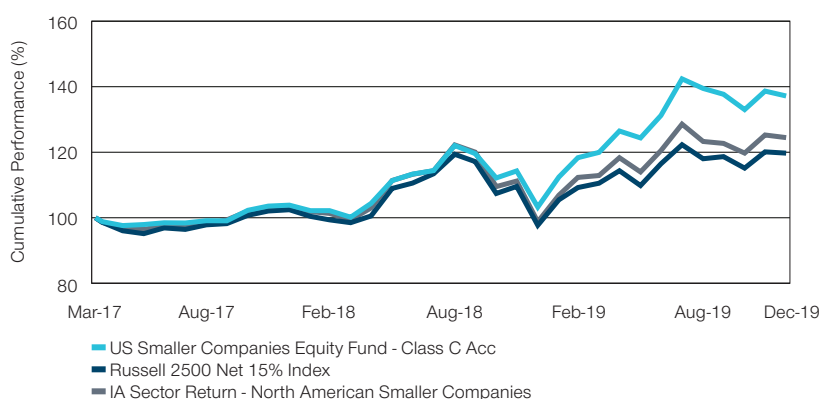

The fund is actively managed and invests mainly in a widely diversified portfolio of shares from smaller capitalisation companies in the United States. Effective 1 June 2019, the “net” version of the indicative benchmark replaced the “gross” version of the indicative benchmark. The “net” version of the indicative benchmark assumes the reinvestment of dividends after the deduction of withholding taxes.

This sector represents the average performance of certain funds that invest at least 80% of their assets in North American shares of companies that form the bottom 20% by market capitalisation.
