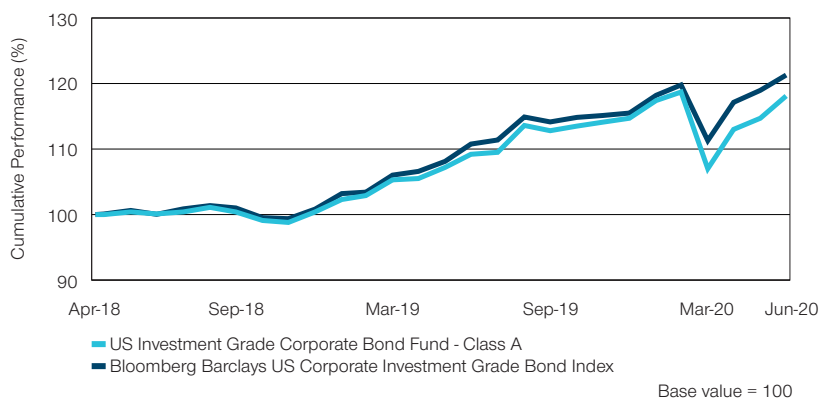
INVESTMENT OBJECTIVE
